

TERMS OF SALE OF PARTICIPATION IN AN EVENT THROUGH THE ONLINE STORE

POLSKIE STOWARZYSZENIE PUZZLOWE

1. General provisions

1. These Terms define the rules for selling the possibility to participate in the event “2nd Polish Speed Puzzling Championship” (hereinafter: the Event), which will take place on 08-09.08.2026 in Olsztyn, through the online store available at: <https://pspuzzlowe.com/en/polish-speed-puzzling-championship-2026/packages/>.
2. The Seller is Polskie Stowarzyszenie Puzzlowe, with its registered office at ul. Stefana Ramuła 33b/10, 81-235 Gdynia, Poland, NIP / Tax ID: 958-17-48-471, REGON: 529814635. The Association is a non-profit organisation. All funds obtained from the sale of registration packages are allocated to the implementation of the Association’s statutory purposes, in particular to the organisation of the “Polish Speed Puzzling Championship”. 3. A Participant of the Event (a competing person) may only be a natural person. Entrepreneurs and other entities may purchase the possibility to participate in the store only for natural persons.
4. The purchase of a registration package constitutes the conclusion of an agreement for the provision of a service consisting in enabling the participant to take part in a sports event organised at a specified time and place, in accordance with the Championship Rules.
5. A registration package does not constitute the sale of goods, but the right to participate in the event, including in particular the organisation of participation in the selected category, the assignment of a starting number, and the possibility to take part in the event.
6. Material elements (e.g. a start package, materials or gadgets) are auxiliary in nature and do not constitute a separate service, but an organisational element of the event.

2. Subject of sale

1. The store sells the possibility to participate in the “2nd Polish Speed Puzzling Championship”, organised by Polskie Stowarzyszenie Puzzlowe. The purchase of a registration package means registration of the participant for the Event.
2. The subject of sale is participation in the Event, which will take place on 08-09.08.2026 in Olsztyn.
3. After payment has been made, the participant receives a registration confirmation together with an individual starting number to the e-mail address provided. The starting number entitles the participant to take part in the selected championship category.
4. The starting number is assigned to a specific person and may not be resold or transferred to another person without the organiser’s consent.

3. Rules for placing orders

1. Orders may be placed 24/7 via the store website.
2. Placing an order requires providing true data and accepting these Terms.
3. The agreement is concluded when the customer receives an order confirmation at the e-mail address provided.
4. In the case of purchasing a registration package for the pairs or team category, the participant is required to provide the details of all members of the pair or team in the order form.

4. Prices and payments

1. All prices shown in the store are gross prices in Polish zloty (PLN).
2. Available payment methods: Przelewy24.
3. Payment for the possibility to participate must be made at the time of placing the order.

5. Delivery of participation confirmation

1. The participation confirmation is sent automatically to the customer's e-mail address after the payment has been credited.
2. The customer is required to check the correctness of the e-mail address before placing the order.
3. If the confirmation of the possibility to participate is not received in the inbox, the customer should check the SPAM folder and then contact the Seller.

6. Rules of participation in the event

1. Each participant who has purchased the possibility to participate in the Event receives a unique starting number assigned to a specific person and to a specific championship category.
2. The starting number entitles the participant to take part only in the category for which registration was made.
3. During on-site registration, the participant is required to present the purchase confirmation or provide the starting number.
4. The starting number may not be resold, transferred or made available to third parties without the organiser's consent. Changing participant details (e.g. in the case of pairs or team categories) may be permitted under the rules set out in the Championship Rules, in particular after notification within the specified deadline and to the specified e-mail address.
5. The Organiser may verify the participant's identity in order to confirm that the data match the registration and for the purpose of collecting the start package, for inspection only, without copying or recording the document.

7. Withdrawal from the agreement and complaints

1. Pursuant to Article 38 point 12 of the Polish Consumer Rights Act, the right of withdrawal from the agreement does not apply to agreements concerning services related to leisure events, if the agreement specifies the day or period of service provision.
2. Due to the nature of the service consisting in organising an event at a specified time and place, Article 38 point 12 of the Polish Consumer Rights Act applies, according to which the right of withdrawal from the agreement does not apply.
3. The customer may submit a complaint regarding the purchase process or delivery of the participation confirmation to the following e-mail address: mistrzostwa@pspuzzlowe.com.
4. Complaints are considered within 14 days. No response to a submitted complaint within 14 days means that the complaint has been accepted.
5. The complaint consideration period is counted from the date on which the complaint is effectively delivered to the specified e-mail address, and the complaint should contain data allowing the order to be identified.

8. Changes to the event

1. The Organiser reserves the right to make changes to the Event programme for reasons beyond its control (e.g. force majeure).
2. If the Event is cancelled, the customer will receive a full refund of the participation fee.
3. Information about changes will be published on pspuzzlowe.com and sent to customers' e-mail addresses.

9. Personal data

1. The controller of customers' personal data is Polskie Stowarzyszenie Puzzlowe.
2. Personal data are processed for the purpose of:
 - processing the order for participation in the event,
 - handling payments,
 - sending the registration confirmation and starting number,
 - handling complaints and contacting the participant.

10. Final provisions

1. These Terms are effective from 01.06.2026.
2. The Seller reserves the right to amend these Terms, provided that such amendments do not affect orders placed before their introduction.
3. In matters not regulated by these Terms, the provisions of Polish law shall apply.
